

## **Notice of Public Hearing**

### **State of Connecticut Health and Educational Facilities Authority Revenue Bonds, University of Saint Joseph Issue**

Notice is hereby given that a public hearing will be held by the State of Connecticut Health and Educational Facilities Authority (the "Authority"), on November 7, 2018 commencing at 10:30 a.m., at the office of the Authority, 10 Columbus Boulevard, 7th Floor, Hartford, Connecticut 06106, for the purpose of providing a reasonable opportunity for interested individuals to express their views, either orally or in writing, on the issuance of the above-captioned bonds (the "Bonds") and the nature of the improvements and projects described below. The Authority has been requested to make available proceeds from the sale of the Bonds to be issued in an aggregate principal amount not exceeding \$30,000,000 which may be issued in one or more series for the purpose of making a loan to the University of Saint Joseph (the "Institution"), a nonprofit institution duly existing under the laws of the State of Connecticut, the mailing address of which is 1678 Asylum Avenue, West Hartford, Connecticut, 06117, to provide moneys to (I) finance the cost of construction, landscaping, furnishing and equipping of an addition and expansion to the O'Connell Athletic Center, including the addition of new parking spaces, located at 1678 Asylum Avenue, West Hartford, Connecticut; (II) finance the construction, furnishing and equipping of a turf athletic field to replace an existing grass athletic field located at 1678 Asylum Avenue, West Hartford, Connecticut; (III) finance the construction, renovation, furnishing, and equipping of the McGovern Student Center also located at 1678 Asylum Avenue, West Hartford, Connecticut; (IV) finance the costs of miscellaneous construction, renovation, improvements, equipment and furniture acquisition at the Institution's facilities located at 1678 Asylum Avenue, West Hartford, Connecticut; (V) refinance the Berkshire Bridge Loan which was issued to provide moneys for (1) financing the costs of the renovation, furnishing and equipping of McAuley and Rosary Halls, located at 1678 Asylum Avenue, West Hartford, Connecticut; (2) financing the costs of renovations and lightings improvements for the O'Connell Athletic Center, located at 1678 Asylum Avenue, West Hartford, Connecticut; and (3) financing the costs of miscellaneous improvements to the Institution's electrical infrastructure located at 1678 Asylum Avenue, West Hartford, Connecticut; and (VI) pay costs of issuance with respect to the Bonds. The facilities financed and refinanced with the proceeds of the Bonds are or will be owned and/or operated by the Institution and are or will be located in the State of Connecticut at the locations as set forth above.

Interested members of the public are invited to attend. Persons desiring to make a brief statement regarding the foregoing projects should give prior notice in writing to the Authority at the address shown below at least 24 hours prior to the hearing. Written comments may be submitted to the Authority at the address shown below. If additional information is required with respect to the above-referenced proposed issue of the Bonds and the projects to be financed with the proceeds thereof in advance of the hearing, please contact the Authority at the address shown below.
