## FY 2024 TARGETED GRANT – ENTERPRISE CAPITAL REVIEW

Mr. Davis introduced Ms. Andrea Levere and Ms. Alexandra Sing from Capitalize Good. Ms. Levere opened the discussion and introduced Ms. Sing to give the presentation regarding Enterprise Capital: All Money is Not Equal, which provided an overview of the following topics:

- What is Enterprise Capital?
- Why Enterprise Capital Matters
- Readiness for Enterprise Capital
- Implementing the Enterprise Capital Strategy into your Portfolio
- Aligning Capital and Capacity Building
- Monitoring and Reporting
- Risks and Mitigants
- Enterprise Capital as it relates to All our Kin and Freedom Reads

The floor was opened to questions and a discussion ensued.

Ms. Weintraub reported on All Our Kin and Freedom Reads. Ms. Weintraub clarified that funding provided by the Authority would be utilized for organizational impact within the state of Connecticut, even though each organization is already in multiple states and has goals to have their programs be nationwide. Ms. Weintraub thanked Ms. Levere and Ms. Sing for their informative presentation, as well as highlighted the financial assessments provided by Capitalize Good.

The Grant Committee then transitioned into a consensus discussion regarding the FY 2024 Targeted Grant – Enterprise Capital Grant Program applications for All Our Kin and Freedom Reads, which involved the discussion of the following topics:

- Social need being fulfilled by each organization and the Enterprise Capital initiative
- Diversity, Equity, and Inclusion (DEI) regarding staffing and future funding needs for All Our Kin
- Enterprise Capital site visit, staffing/management infrastructure, and development of impact metrics for Freedom Reads
- Long-term sustainability and measurement of success (e.g., fortification of balance sheet v. organizational impact metrics) of the Enterprise Capital initiative
- Support that can be provided to each organization (e.g., financial technical assistance, networking with additional funders)

Mr. Davis requested a motion to award a \$250,000 Enterprise Capital grant to All Our Kin under the FY 2024 Targeted Grant – Enterprise Capital Program. Mr. Elbaum moved for approval and Mr. Lisi seconded the motion.

Mr. Elbaum inquired about each organization's requested grant amounts and the distribution of funds. Mr. Lisi also commented about phasing the funding over several years rather than an upfront allotment, and Ms. Martin commented that upfront funding may better align with the mission of Enterprise Capital. Ms. Weintraub reported that the requested amounts from each

organization were provided by the organizations and commented on the historical award amounts for the Targeted Grant Program. A discussion continued.

Mr. Lisi proposed a reduction to the proposed award to Freedom Reads from \$750,000 to \$250,000. A discussion ensued.

Mr. Davis requested an amended motion to award a \$400,000 Enterprise Capital grant for Freedom Reads for the FY 2024 Targeted Grant – Enterprise Capital Program. Mr. Elbaum moved for approval and Mr. Davis seconded the motion.
