

NOTICE OF PUBLIC HEARING  
STATE OF CONNECTICUT HEALTH AND EDUCATIONAL FACILITIES AUTHORITY

Notice is hereby given that a public hearing will be conducted by the State of Connecticut Health and Educational Facilities Authority (the “Issuer”) at 11:00 a.m., on Tuesday, December 2, 2025, via the following toll-free telephonic conference line:

The purpose of the hearing will be to consider the proposal of The Trustees of Trinity College (together with its affiliates, the “Borrower”) that the Issuer issue qualified 501(c)(3) bonds (as defined in Section 145 of the Internal Revenue Code), in an aggregate amount not to exceed \$42,000,000, to finance and refinance certain higher educational facilities owned and operated by the Borrower for educational purposes and located or to be located at the Borrower’s main campus in Hartford, Connecticut, roughly bounded by Allen Place (North), Broad Street (East), New Britain Avenue (South) and Summit Street (West) (the “Campus”), or adjacent or proximate sites. The new projects expected to be financed include, but are not limited to, (i) utility renovations and improvements (including renovations and improvements to underground infrastructure for steam and chilled water distribution systems), (ii) additions and upgrades to athletic facilities, (iii) renovations and improvements to student housing, (iv) renovations and improvements to academic facilities, (v) renovations and improvements to other campus facilities and/or (vi) equipment and furnishings for any of the foregoing projects. Proceeds of the bonds are also expected to be used to refinance certain previously issued debt that financed projects on the Campus.

Interested persons wishing to express their views on the projects and the proposed issuance of qualified 501(c)(3) bonds to finance and refinance the projects will be given the opportunity to do so at the public hearing or may, prior to the time of the public hearing, submit their views in writing at the address shown below. Persons desiring to speak during the telephonic public hearing should give notice in writing to the Issuer at least 24 hours prior to the hearing by email to Daniel Kurowski, Assistant Director at [dkurowski@cheffa.com](mailto:dkurowski@cheffa.com).
